The affiliation is subject to fulfillment of the following deficiencies in the Institution/college pointed out by the Expert Visit Committee/Inspection Committee in their report/ recommendations.

- Institution is required to speed up the construction work of new campus at Rahi Dhar, VPO-Bagsaid, Tehsil-Thunag, Distt-Mandi (HP) and complete the same during the academic year 2022-23.
- Institution is required to establish supporting infrastructure/labs for conducting the practical's as per curriculum on priority basis.
- Institution is required to initiate the process for construction work of boys and girls hostel and residences for faculty and staff need to be constructed.
- Faculty cadre ratio needs to be maintained.
- More legal software and software related to course be procured.
- Institution is required to appoint more Teaching and Non-Teaching Staff and Lab Technician as per norms on priority basis for the academic session 2022-23.
- Institution is required to ensure the registration/participation of all the students and faculty on SWAYAM portal/MOOC courses.

The above mentioned approval is further subject to following conditions failing which the process of disaffiliation will be initiated.

- a) Submission of compliance report in respect of above deficiencies along with documentary evidence within a period of one month from the date of issuance of this letter.
- b) No excess admissions shall be made by the Institution over and above the approved intake by the PCI/HPTU.
- c) The institution will not close or start new course(s) or alter intake capacity of seats without prior approval of the AICTE/PCI/HPTU.
- Institution shall not charge tuition and other fees than as prescribed by the Govt. of Himachal Pradesh / HP Technical University. No capitation fee, Industrial training fee, creation of examination center, fine for attendance, etc. shall be charged from the students in any form.
- e) The institution shall comply strictly with the provisions made under the Anti-Ragging Regulation notified by the UGC/PCI/HPTU/State Government for prevention and prohibition of ragging in Institution/College.
- The institute will follow the admission procedure, University Calendar, syllabus, examinations procedure and other norms/standards as laid down by the HPTU
- The institution is required to submit the copy of PCI approval for the academic session 2022-23.
- As per provision applicable in Himachal Pradesh Technical University, Ordinance h) No.61, Chapter -IV, Clause 9 (ix-x) and Schedule-V, the institution may, if so desires submit appeal for consideration by the Standing Appeal Committee within ten days from the date of issue of this letter.
- Institution is required to submit the compliance of the decision of the 381 meeting of Executive Committee of Pharmacy Council of India (to appoint faculty as per statutory provisions of Education Regulations i.e. Minimum Qualification for Teachers in Pharmacy Institutions Regulations, 2014 and the Bachelor of Pharmacy (B.Pharm) Course Regulations, 2014) with in the six months to the Pharmacy Council of India.
